CHILD PROTECTION - OUR STAFF IDENTIFIED A HIGH RISK SITUATION WITH ONE OF OUR PRIMARY GIRLS THAT REQUIRED URGENT CHILD PROTECTION. IT WAS DETERMINED THAT SHE WAS AT RISK OF ABUSE AND AS SUCH SHE SPENT HER SCHOOL HOLIDAYS AT A LOCATION CLOSELY MONITORED BY COU'S SOCIAL WORKER. AS A RESULT OF COU'S SOLID PROJECT MANAGEMENT AND LEADERSHIP - 322 CHILDREN WERE FREED FROM CHILD LABOR AS WELL AS THE STRONG PARTNERSHIP WAS DEVELOPED WITH COMMUNITY MEMBERS, DISTRICT LEADERSHIP AND OTHER GOVERNMENT DEPARTMENTS.

COU STAFF AND A VISITING BOARD MEMBER IDENTIFIED A YOUTH-HEADED HOME (THAT HOUSED ONE OF OUR STUDENTS) THAT WAS NOT SANITARY, SAFE OR SECURE FOR ANYONE IN THE HOME. 4 STAFF AND THE BOARD MEMBER DEVOTED SEVERAL HOURS OVER THE COURSE OF TWO DAYS TO REFURBISH, CLEAN AND SECURE THE HOME. THIS WAS A MAJOR ENDEAVOR WITH THE GOAL BEING TO PROVIDE OUR SPONSORED CHILD AND HIS BROTHERS A SAFER AND MORE SECURE HOME. WE ALSO PROVIDED THE HOME WITH BASIC LIVING NECESSITIES AND THE CHILD'S US SPONSOR LATER SENT FUNDS TO START AN INCOME GENERATING BUSINESS FOR THE OLDEST BROTHER.
