During 2017 over 200 children were enrolled in primary, secondary vocational and university schools. The organization also increased access to education for the newest recruits.

To improve access to basic health care services, counseling and psychosocial support programs.

In partnership with Alive Medical Services (AMS), general medical check-ups were performed for students from the Kampala/Mukono operational areas. The impact on the children is that they remain strong and healthy and thus able to concentrate on their studies and perform at their best.

To develop consistent advocacy and empowerment programs that raise commitment to the welfare of vulnerable children.

The organization participates in sub-county OVC coordination meetings. This enabled additional support for COU supported OVC at the sub county level and increased visibility of the organization through increased shareholder engagements.

The organization also participated in annual general meetings at the partner schools and COU continued to force strong partnerships with the school and their head teachers. This was another key opportunity that
